



Terms and Conditions

1. The promoter is Netball Australia (ABN 66 003 142 818) of 191 Johnston Street, Fitzroy, Victoria, 3065 (Promoter).
2. Entry into the Fast5 Netball Competition (Promotion) is deemed acceptance of these Terms and Conditions (Terms).
3. Entry is open to attendees of the Fast5 Netball World Series except:
 - a. Employees of the Promoter and their immediate family members;
 - b. Persons who have breached the Terms of any promotion run by or on behalf of the Promoter (Entrants).
4. The Promotion commences on 29 October 2016 at 12:00 pm (AEST) and concludes on 30 October 2016 at 7:30 pm (AEST) (Promotion Period).

How to Enter

5. To enter the competition, Entrants must attend the Fast5 Netball activation then:
 - a. Register their name and contact details to participate in the activation;
 - b. In the allocated time, shoot as many points as possible; _____
 - c. Read and agree to these Terms.

13. The Fast5 Netball social media channels will announce the winner publicly on the day of the prize draw.
14. The Promoter will contact the winner to arrange for delivery of prizes won.
15. The Promoter reserves the right in its sole discretion to select alternate winner/s if it determines that the winner/s do not adequately satisfy these Terms.

17. If the prize is unavailable, the Promoter reserves the right in its sole discretion to substitute for the prize with another prize of equal value as determined by the Promoter. The Promoter accepts no responsibility for any variation in prize.

General Terms

20. The Promoter reserves the right in its sole discretion to verify, or require the Entrant to verify, the Entrant's identity, eligibility to enter the Promotion, entry submitted and compliance with these Terms.
21. If there is a dispute about the identity of the Entrant, the Promoter reserves the right in its sole discretion to determine the identity of the Entrant.
22. All entries become the property of the Promoter. By entering the Promotion, Entrants:
 - a. Grant the Promoter a royalty free, perpetual, non-exclusive, irrevocable licence to keep, store, reproduce, publish all or part of their entry.
23. Entrants acknowledge and agree that

28. Each Entrant indemnifies and keeps indemnified the Promoter against all claims, losses or damages and expenses suffered by the Promoter or any third parties arising out of the breach of these Terms, the conduct of the Entrant in relation to the Promotion, or use of the Prize.
